

Privacy Policy for Paultons Cricket Club

Effective Date: November 24

Paultons Cricket Club (“Paultons CC,” “we,” “us,” or “our”) values your privacy and is committed to protecting the personal information we collect from members, visitors, and other individuals associated with the club. This Privacy Policy explains how we collect, use, and protect your data in accordance with applicable data protection laws, including the UK General Data Protection Regulation (UK GDPR) and the Data Protection Act 2018.

1. Information We Collect

We may collect the following types of personal information:

a. Member Information

- Name
- Date of birth
- Contact details (e.g., phone number, email address, home address)
- Emergency contact details
- Payment or bank information (for membership fees or donations)
- Medical information (for safeguarding player welfare, where relevant)

b. Participant and Visitor Information

- Name and contact details for event participants and visitors
- Photos or videos taken at matches or events (for promotional purposes, with consent)

c. Website or Online Interaction

- IP addresses and browsing data from our website (if applicable)
- Online registration or communication data

2. How We Use Your Information

We use your personal information for the following purposes:

- **Membership Administration:** To manage memberships, including registration and renewals.
- **Event Management:** To organize and promote matches, training sessions, and other club events.
- **Health and Safety:** To ensure player safety and manage medical emergencies.
- **Communication:** To share club updates, event information, or membership notices.
- **Legal Obligations:** To comply with relevant laws, including child protection regulations.
- **Marketing and Promotion:** To promote the club through newsletters, social media, or promotional materials (with explicit consent).

3. Sharing Your Information

We do not sell or share your personal information with third parties except:

- To governing bodies like the England and Wales Cricket Board (ECB) for cricket-related administration.
- To service providers or partners assisting with club operations (e.g., payment processors or event organizers).
- When required by law or to protect the safety of individuals.

4. Data Security

We take appropriate technical and organizational measures to protect your personal information against unauthorized access, loss, or misuse.

5. Data Retention

We retain your personal information only as long as necessary for the purposes outlined in this policy, including legal and regulatory obligations.

6. Your Rights

You have the right to:

- Access your personal data and request a copy.
- Correct inaccurate or incomplete information.
- Request the deletion of your data (where applicable).
- Object to certain uses of your data, such as marketing communications.
- Lodge a complaint with the Information Commissioner's Office (ICO) if you believe your rights have been violated.

7. Consent and Children's Data

For members or participants under 18, we require parental or guardian consent to collect and process personal information.
